

# Legal notice

## Legal notice & data protection

Based on the Organic Law 15/1999 of December, 13<sup>th</sup>, related to Personal Data Protection and on the Law 34/2002 of July 11, related to Services of the Information Society and Electronic Commerce, we inform you that your visit to this website is subject to the terms and conditions set forth in this Policy on Personal Data Processing (“the Policy”).

## Privacy Policy

When you provide us with personal information through the website <https://HappyDaystress.com> (“the Website”), Annabel Lemétais (“the Owner”), with address Calle Tavern, 33, Atico 2, 08006 Barcelona, your privacy and the rights granted by the regulation on personal data protection will be respected. As such, it is important that you understand which information we gather about yourself during your visit to the Website and what we do with this information.

We will not share your personal information with a third party except as set forth in this Policy. The Owner will reveal information related to your personal data if necessary to comply with any legal obligation.

## Collection and use of the information

By providing us with your personal information on the Website, you agree to the processing and communication of your personal data in accordance with the terms of this Policy. Should you wish the Owner not to gather information about yourself, we ask you to not provide it. The Owner will use the personal information you provide without personal identification for internal use, such as the elaboration of statistics. As such, the Owner will be able to gather, store or collect non personal information with regards to the use of the Website, such as for instance information that indicates which of the Website’s pages are most popular.

## Cookies and log files

The Owner may place a “cookie” in the hard disk of your laptop in order to recognize you as a frequent visitor and personalize your use of the Website. The cookie will be stored in the hard disk of your computer until you delete it. You can set your browser to be informed of the presence of cookies or reject them automatically. If you reject cookies, you will still be able to use the Website even if it may imply a limitation in the use of some of the features or prevent an optimum use of the Website.

## Third parties

The Owner may contract third parties to carry out duties on its behalf with regards to the purposes for which your personal data is being collected, like for instance, analyse the information provided, host websites or provide logistics services. These third parties may have access to the personal information needed to perform their duty, even if they will not be able to use the aforementioned

information for any other purpose and we will adjust our relationship with these third parties as requested by the applicable personal data protection regulation.

### **Hyperlinks**

The Website may contain links to other websites. The Owner does not take responsibility for the practices followed by other websites with regards to personal data processing. The Policy is only applicable to the information collected on the Website. We advise you to read the policies on personal data processing of other websites towards which or from which the Website hyperlinks or visits in any other form.

### **Security**

The Owner has implemented several measures to protect the security of your personal information, both online and offline.

### **Notification of changes**

The Policy can be modified by the Owner at any time and will be regarded as applicable from that moment onwards. In such case, the revised policy will be uploaded onto the Website and if you are a registered user, we will send it to you by e-mail. If you are a registered user and you do not respond to the referred e-mail within 30 days, your silence will be considered as a consent to the new policy on personal data processing.

### **Access rights, correction, cancelation and opposition**

You have the right to exercise your right of access, correction or cancellation of your data or oppose yourself to the processing of your personal data, with a communication by e-mail

### **Applicable law**

The applicable law in case of dispute or conflict of interpretation of the terms of this legal notice, the Policy, as well as any other issue related with the services of the Website is the Spanish law.
